Unconditional Obligation

I/we understand the following:

1. All Fees are Non-Refundable and due upon enrollment.
2. If enrollment process is not completed for any reason, this amount is forfeited.
3. I understand that I am required to provide a valid Driver's license to keep on record for security reasons.

School's Rights Reserved

The School reserves the right to insist upon the immediate removal of any person(s) whose presence is considered harmful either to the students or the School's best interest. Inappropriate behavior and/or aggression displayed by any person(s) will not be tolerated and will result in the student's immediate dismissal. In case of dismissal, the parents/guardians shall remain liable for the full tuition and all other financial obligations.

Trent reserves the right to exclude students from classes and other school activities after appropriate notice has been sent to parents/guardians regarding late payments. Disciplinary issues, such as but not limited to conduct, inappropriate behavior, aggression and/or not meeting academic requirements set by Trent will be considered violation of the terms of this contract. If problems persist, Trent may dismiss the student and the parents/guardians shall remain liable for the full tuition. In case of non-payment, all exams and transcripts will be marked "incomplete" and withheld until all financial obligations have been met. The school may suspend a student for non-payment and the parents/guardian shall remain liable for the full tuition and all other financial obligations. Parents/Guardians acknowledge that if this account is turned over to an attorney due to any disputes, all fees incurred by the School will be assessed to the student's account and payable by parents/guardian.

Liability:
